SAT 28 - SUN 29 OCTOBER 2017

1. **Introduction.** As a follow on from last season’s very successful season the 2017/18 season will open with Army trials Sat 28 – Sun 29 Oct 17. This Calling Notice is being sent to all last season’s squad members. Attendance is also for those who wish to be considered for the Open and Development Army Netball Squads for the Inter Service Netball Championships in March 2018. The Army coach, Maggie Jackson, will be in attendance during these trials; Maggie Jackson would like to encourage new triallists to take part who have not been involved in the Army Netball Squad previously. The trials will commence at 0900 on Sat 28 Oct 17 at the Aldershot Garrison Sports Centre (AGSC) and all players are expected to arrive ready to play. Selection will be completed and the long squad announced by 1500hrs on Sunday 29th Oct 17. The trials will involve training and match play. 4. **Dress and Equipment.** Players are to arrive in black tracksuit bottoms and black ARMY NETBALL hoodies, if they have them. Players should bring black shorts and red ARMY NETBALL t-shirts to train in, again if they have them, if not any red t-shirt will suffice. All players are to bring ample food and water, sufficient for all day as breaks will be minimal, this is to enable maximum training and trial time with the ANA coach.

All travel arrangements are to be by the cheapest and most economical means and coordinated so as individuals travelling from the same or near unit locations travel together.
